Range 8 East of the Willamette Meridian, running thence North 19 Nineteen Rods 14 feet, thence West Ten (10) Feet thence South Nineteen (19) Rods and Fourteen (14) Feet, thence East Ten (10) Feet to the place of beginning, containing about one eleventh of an acre more or less.
