

HAFFEY TO HAFFEY.

THIS INDENTURE WITNESSETH, That Clancie G. Haffey, of Cape Horn, County of Skamania, State of Washington, party of the first part, for and in consideration of the sum of Ten Dollars (\$10.00), in lawful money of the United States of America, and other good and valuable considerations, to her in hand paid by Bernard A. Haffey, her husband, of the same place, the party of the second part, the receipt whereof is hereby acknowledged, has granted, bargained and sold, and by these presents does grant, bargain, sell and convey unto the said party of the second part, and to his heirs and assigns, the following described tracts, pieces or parcels of real property, situate, lying and being in the County of Skamania, and State of Washington, to-wit:

The Southwest quarter of the Northeast quarter (S.W. $\frac{1}{4}$) of N.E. $\frac{1}{4}$) of Section Four (4), in Township One (1) North, of Range Five (5) East, of Willamette Meridian, excepting therefrom the East half of the East half of said Southwest quarter of the Northeast quarter, the amount of land hereby conveyed being Thirty (30) acres.

The South half of the Southeast quarter (S. $\frac{1}{2}$ of S.E. $\frac{1}{4}$) of Section Thirty-two (32), in Township Two (2) North, of Range Five (5) East, of Willamette Meridian, containing Eighty (80) acres.

Commencing at the Northwest corner of the real estate of the Estate of William Haffey, Deceased, running thence South along the West line of said real estate of said Estate Eighty-four (84) rods and Sixteen (16) links to the Northwest corner of that portion of real estate set off or apportioned out of said Estate to James Haffey; thence East along the North line of that portion of real estate set off or apportioned out of the said Estate as aforesaid to the West line of that portion of real estate set off or apportioned out of said Estate to Frank Haffey; thence North along said line of said real estate so set apart or apportioned to said Frank Haffey to the North line of said Estate; thence West along said North line of said Estate to the place of beginning, said described real estate containing Seventeen and One-fifth (17 $\frac{1}{5}$) acres, more or less, and being a portion of the real estate of said Estate.

Commencing at a post on the Northeast corner of a portion of land owned by Bernard A. Haffey (said post being on the East line of the real estate of the Estate of William Haffey, Deceased, Thirty-nine (39) rods and Nine (9) links North of the Southeast corner of said Estate), thence North along the East line of the Estate of said William Haffey, Deceased, Fifteen (15) rods and Seventeen (17) links; thence West parallel with the North line of the real estate owned by Bernard A. Haffey Eighty (80) rods and Sixteen (16) links; thence South Fifteen (15) rods and Seventeen (17) links to the Northwest corner of that portion of real estate owned by Bernard A. Haffey; thence East along the North line of that portion of real estate owned by said Bernard A. Haffey Eighty (80) rods and Sixteen (16) links to the place of beginning, containing Eight (8) acres. Also the following described portion of real estate; Commencing at the Northeast corner of the Estate of William Haffey, Deceased, thence running South along the East line of said Estate Seventeen (17) rods and Twenty (20) links; thence West parallel with the North line of said Estate Seventeen (17) rods and Twenty (20) links; thence North parallel with the East line of the real estate of said Estate seventeen (17) rods and Twenty (20) links to the North line of the real estate of said Estate; thence East on the North line of the real estate of said Estate to the place of beginning, containing Two (2) acres, making in all Ten (10) acres and being a portion of the real estate of said Estate of William Haffey, Deceased.

Commencing at the Southeast corner of the Homestead heretofore set apart by order of Court for the use of Mrs. Catherine Haffey and her minor child, and run thence East along the South line of the real estate belonging to the Estate of William Haffey, Deceased, Eighty (80) rods and Sixteen (16) links to the Southeast corner of said real estate belonging to said Estate; thence North along the East line of said real estate belonging to said Estate Thirty-nine (39) rods and Nine (9) links; thence West Twenty (20) degrees and Thirty (30) minutes Eighty (80) rods and Sixteen (16) links to the East line of said Homestead; thence South along the East line
