

Waiver for Claim of Damages and consent to locate Road

In the matter of petition of Town of Stevenson
County
for a Road to be known as Extension of Second St.

We the undersigned being the owners of the property herein described do in consideration of the benefits and advantages to accrue to us by the location and establishment of the above Road hereby consent that said street be established as described in the petition herei and as examined and surveyed, and forever relinquish by consent to the town of Stevenson Washington a right of way 60 feet in width over and across the following described piece or parcel of land to-wit: Beginning at a point 270.00 feet west and 29.00 feet south of the $\frac{1}{4}$ government corner on the north boundary of section 1 Twp. 2 N.R.7 E.W.M. thence S 35° 12' E 509.80 feet to the west boundary of the Udell Estate as surveyed by the County Engineer May 13th 1912 and waive all claim for damages of whatever kind which may be occasioned to said land or any portion thereof by examining surveying laying out and establishing said Road.

Giving and granting unto said Town of Stevenson Washington the said right of way with full power and authority to examine survey lay out and establish said road as proposed and to perpetually maintain the same as a County Road.
