## WARRANTY DEED

THE GRANTORS, Erick Bylin and Anna Bylin, husband and wife, of Home Valley, Skamania County, State of Washington, for and in consideration of One Dollar and other valuable considerations, to them in hand paid, convey and warrant to School District No.11, Skamania County, Washington, the following described real estate, situated in the County of Skamania State of Washington, to-wit:- Beginning at a point Fifteen (15) Feet East of the South West corner of the North East Quarter of Section Twenty Three (23), Township Three (3), North, Range 8, East of the Willamette Meridian, running thence North Fifty Eight (58) Feet; thence North East One Hundred Forty-Seven (147) Feet, thence South Ninety (90) Feet, thence West about One Hundred Forty Five (145) Feet; to the point of beginning. It is mutually understood by the Grantor and the Grantee of these premises that title hereby granted shall continue in the grantee only for so long as the above described lands shall be used for school or public purposes, and all interest of this grantee to the above described lands shall be abrogated when said lands shall be no longer used for purposes as above specified.

A material consideration for the transfer of the above described lands is that the grantee shall fence these granted lands by good wire fence from adjoining lands of this grantor.
