in this grantee for so long a time only as above described lands shall be used for school orrpublic purposes; and all interests of this grantee or its assigns in the above described lands
shall be abrogated when said shall no longer be used as above specified.

It is a material consideration for the transfer of the above described lands that the grantee shall fence these granted lands by good wire fence from adjoining lands of these grantors.
