Howell party of the second part, has Granted, Bargained and Sold, and by these presents do Grant, Bargain, Sell and Convey unto the said party of the second part, and to her heirs and assigns, the following described real property, situate, lying and being in the County of Skamania State of Washington, to-wit: Beginning at a point 15.4 feet west of the quarter post on the south side of section 36 Township 3 North of Range 7 East of W.M. thence west 274.3 feet, thence North 5° 30' West 465.4 feet, thence south 74° East 241 feet, thence south 11° 19' east to the point of beginning, containing three (3) acres more or less. To Have and To Hold, the said premises, with all their appurtenances, unto the said party of the second part and to her heirs and assigns forever; and the said Albert R.Greene and Julia C.
