the above entitled court to be paid out under the direction of said court or judge thereof.

It is now Considered Ordered and decreed that the petitioner Northwestern Electric company appropriate the following described rights of way and appurtenances to-wit:

Two rights of way for electric power transmission lines including the right to cut such timber or brush as interfers with or endanger said lines out to a distance of 150 feet on eigher side of said lines across the following described property to-wit:

The southwest quarter of the southwest quarter of section twenty nine and that portion of the southeast quarter of section thirty which lies between the county road and the right of way of the Spokane Portland & Seattle Railway all in Township three North of Range eight East of Willamette Meridian and located in Skamania County Washington. The first of above mentioned rights of way is described as follows to-wit: A right of way 12 feet in width to build maintain and operate an electric poer transmission line thereon, the center line of said right of way to be located as follows: Commencing at a point 620 feet south of the northeast corner of said southwest quarter of the southwest quarter of section twenty nine and running thence in a south# westerly direction in a straight line to a point in the west line of said southwest quarter of said southwest quarter of said section twenty nine and thence in a straiht prolongation across the said tract described above as being in said section thirty, as surveyed staked out and located together with the right to enter upon a strip of land along said entire line as surveyed staked and located and six feet in width on each side of said line for the purpose of building maintaining and examining and operating said transmission lines. The second of the to rights of way for transmission lines mentioned above is described as foollows to-wit: A right of way le feet in width to build operate maintain and operate celectric poer transmission line thereon the center line of said right of way to be located along a line parallel with the center line of the righ of way first above described and fifty feet distant therefrom in an northerly diffection together with the right to enter upon a strip of land along the entire lenght of the line on which the second transmission line will be located as above decribed and six feet in width on each side of said line for the purpose of building maintaining examining and operati g saidt ransmission line; together with the right to cut such timber and brush as interfers with or endangers either of said transmi sion lines out to a distance of 150 feet eo either side of the center lines of the two rights of way above described Subject however to the conditions that the petitioner shall not have the right to fence or otherwise inclose eighter of said right of way or any part thereof; and subject to the further condition that the poles to be erected by the petitioner on said roghts of way shall in no case be less then thee hund ed (300) feet apart on each separate right of way, provided this shall not be construed to prevent the petitioner from placing poles on one right of way within three hundred feet of poles on the other right of way.
