BUSHLACH et ux to TILLAMOOK COUNTY BANK.

THIS INDENTURE, Made and entered into this 13th day of December 1918 by and between Phillip C. Buslach and Alyce H. Buslach, husband and wife of Tillamook Ore., parties of the first part, and Tillamook County Bank of Tillamook Oregon, party of the second part.

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Twenty Three Hundred 00/100 Dollars, to us paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey unto the said party of the second part, its heirs and assigns, all the following bounded and described real property, situate, lying and being in the County of Skamania and State of Washington, to-wit:

The South West Quarter of the North West Quarter (SW $\frac{1}{4}$  NW $\frac{1}{4}$ ) and the North West Quarter of the South West Quarter (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) and the South Half of the South West Quarter (S $\frac{1}{2}$  SW $\frac{1}{4}$ ) all in Section Four (4), and the South Half of the North East Quarter (S $\frac{1}{2}$  NE $\frac{1}{4}$ ) and the North West Quarter of the South East Quarter (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ) all in Section Five (5), all the above described land being in Township One (1), North Range Five (5), East of the Willamette Meridian and containing two hundred eighty acres more or less according to the Government Survey thereof.

The said parties of the first part hereby agree that they will, not later than ten days before the same become delinquent, pay and extinguish all taxes and other public charges that may be levied or assessed against the said premises or this mortgage or the note hereby secured, and the insurance premiums for the insurance hereinafter specified,
