Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following
described piece or parcel of land, to-wit: The Northwest quarter of Section Thirty-one 31
Township (2) two N.R.5 East of the Willamette Meridian and waive all claims for damages of
whatever kind which may be occasioned to said land or any portion of the same, by examining,
surveying, laying out and establishing said Road.

full power and authority to examine, survey, lay out and establish said Road as proposed,
and to perpetually maintain the same as a County Road.

WAIVER OF CLAIM FOR DAMAGES AND CONSENT TO LOCATE ROAD

In the Matter of the Petition of
State Road No. 8 et al.
For a County Road to be known as the
State Road Road.

We, the undersigned, being the owners of the property herein described,
do, in consideration of the benefits and advantages to accrue to me by the location and
establishment of the above proposed County Road and the sum of one hundred and ninety-five
dollars I hereby consent that said road be established as described in the petition herein
and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way sixty
feet in width over and across the following described piece or parcel of land, to-wit:
the northwest quarter of the southwest quarter and the southeast quarter of the southwest
quarter of section 31, township two north of range five east Will. Mer. Skamania County Washing-
ton and waive all claims for damages of whatever kind which may be occasioned to said land or
any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-way, with
full power and authority to examine, survey, lay out and establish said Road as proposed, and
to perpetually maintain the same as a County Road.
