all lawful ways and means for the recovery of the principal and interest of said indebtedness, and in case of payment to discharge the same as fully as they might or could do if to
these presents were not made; and to commence and prosecute to final judgment any action
or suit to collect said debt or to foreclose said mortgage, and to compromise and settle the
same before judgment, and to enforce satisfy and discharge any judgment that may be recovered therein.
