Relton and Cora Ethel Relton (his wife) and Sydney Relton (a bachelor) of the County of Skamania, and State of Washington, hereinafter called the Mortgagors, and Nath Rosenbaum of Salt Lake City, Utah, hereinafter called the Mortgagee,

WITNESSETH: That the said Mortgagors, for, and in consideration of the sum of Five thousand & no/100 (\$5,000.00) Dollars, United States Gold Coin, to them in hand paid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed and by these presents do grant, bargain, sell and convey unto the said Mortgagee his heirs, legal representatives and assigns, those certain premises situate in the County of Skamania, and State of Washington, and described as follows to-wit:
