the undersigned, being the owners of the property herein described, do, in consideration of the benefits and advantages to accrue to \_\_\_\_\_ by the location and establishment of the above proposed State Road, hereby consent that said road be established as described in the petition herein and as surveyed, and forever relinquish to \_\_\_\_\_ County, Washington, a Right-of-Way Sixty (60) feet in width over and across the following described piece or parcel of land, to-wit: N½ of SE¼ of Section 4 Tp. one N.R.5 E of Willamette Meridian, and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road. Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examing, survey, lay out and establish said Road as proposed and to perpetually maintain the same as a County Road.

WAIVER OF CLAIM FOR DAMAGES AND CONSENT TO LOCATE ROAD

In the Matter of State Road to be known as the Lyle-Washougal State Road.

I, the undersigned, being the owner of the property herein described, do, in consideration of the benefits and advantages to accrue to me by the location and establishment of the above proposed State Road, and the further consideration of \$540.00 in hand paid hereby consent that said road be established as described and as surveyed, and forever relinquish to Skamania County, Washington, a Right-of-Way 60 feet in width over and across the following described piece or parcel of land, to-wit:

SW¼ of Sec.3 Tp.1 N.R.5 E.W.M. according to present survey the old Road across said land to be vacated as soon as state road is completed and ready for travel across said land, said State road being 80 rods long. and waive all claims for damages of whatever kind which may be occassioned to said land or any portion of the same, by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way with full power and authority to examine, survey, lay out and establish said Road as proposed, and to perpetually maintain the same as a State Road.
