Henderson of Hood River, Oregon party of the second part, have GRANTED, BARGAINED and SOLD, and by these presents do Grant, Bargain, Sell and Convey unto the said party of the second part, and to his heirs and assigns, the following described real property, situate, lying and being in the County of Skamania State of Washington, to-wit:

Lots 1, 2, and 3, Block 2, Hamilton's Second Addition to the Town of Underwood according to the official plat thereof filed with the County Auditor of Skamania County and recorded in the records of said County and State. Said lots are further described as follows: Beginning 667.5 feet North and 30 feet East of a stone or bar marking corner to S.W. corner of N.W. one fourth of N.W. one fourth Section 23, Tp. 3 N. Range 10 E. Wil. Mer.; thence east 95 feet, thence South along West side of 10-foot alley 138 feet, thence west 95 feet to Cooper Avenue, thence North along East side of Cooper Avenue 138 feet to the place of beginning, being in the Northwest quarter of aforesaid Block 2.
