

## HOOD LAND COMPANY TO SHEEHY

KNOW ALL MEN BY THESE PRESENTS, that whereas the Hood Land Company, a corporation duly organized and existing under the laws of the State of Oregon, heretofore about the month of May, 1911, conveyed by deed to William Sheehy all of the standing and fallen timber on the north half of the northwest quarter of Section 8, Township 3 North, Range 10 East, W.M., in Skamania County, Washington; and

WHEREAS said deed has been lost, and the said William Sheehy died testate in the month of July, 1912, making in effect his wife, Alice Sheehy, devisee of the property above mentioned; and

WHEREAS it is satisfactory to the heirs, legatees and devisees of the said William Sheehy that the said Hood Land Company should quitclaim its interest in said property to the said Alice Sheehy;

NOW THEREFORE, in consideration of the premises and the sum of one dollar to it in hand paid by the said Alice Sheehy, the receipt whereof is hereby acknowledged, the Hood Land Company hereby remises, releases and forever quitclaims to the said Alice Sheehy all its right, title and interest in and to the standing and fallen timber on the north half of the northwest quarter of Section 8, Township 3 North, Range 10 East, Willamette Meridian, in Skamania County, Washington.
