

CASCADE LAND & INVESTMENT COMPANY TO State of Washington.

Right of Way Deed.

IN THE MATTER OF STATE ROAD NO. 8, OTHERWISE KNOWN AS THE COLUMBIA RIVER ROAD.

KNOW ALL MEN BY THESE PRESENTS, That the Cascade Land and Investment Company, a corporation of the State of Washington, in the consideration of the benefits and other valuable considerations, and the sum of One Dollar, paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the State of Washington, the following described parcel of land, situated in Skamania County, in the State of Washington, to-wit: A strip of land 60 feet wide except where noted below, being 30 feet, except where noted, on each side of line of said road as surveyed over and across lot 6 Section 11 and the Northeast quarter of the Southeast quarter of Section 10 being in the I.H. Bush Donation Land Claim No. 296, except from station 80 to station 83 being a strip of land 100 feet wide, being 50 feet on each side of line of said road as surveyed; and over and across Lot 1 Section 14, except from Station 182 to Station 187 being a strip of land 80 feet wide, being 40 feet on each side of line of said road as surveyed; and over and across Lot 1 Section 15, and all land owned by the Cascade Land and Investment Company within the following boundaries: A strip of land being in Lots 3 and 2 in Section 22 being 60 feet wide, 30 feet on each side of line of said road as surveyed from Station 202 to Station 209; and being 50 feet wide on the North side and 30 feet more or less on the South side of line of said road as surveyed from Station 209 ~~XXXXXX~~ to Station 219 plus 50; and being 150 wide on the North side and 30 feet more or less on the South side of line of said road as surveyed from Station 219 plus 50 to Station 231; and 60 feet wide, being 30 feet on each side of the line of said road as surveyed from Station 231 to about Station 238 and ending in the present County road, being in the F.A. Chenowith Donation Land Claim all in Township 2 North, Range 7 East W.M.

TO HAVE AND TO HOLD the same, unto the State of Washington for the purpose of a public road forever.
