

SKAMANIA COUNTY TO STATE OF WASHINGTON

IN THE MATTER OF STATE ROAD NO 8, OTHERWISE KNOWN AS Columbia River, Road.

KNOW ALL MEN BY THESE PRESENTS, That Skamania County, a municipal corporation of the state of Washington, in consideration of the benefits and other valuable consideration, and of one dollar, the receipt whereof is hereby acknowledged, has hereby granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the State of Washington, the following described easments for public roads, to-wit;

A strip of land 60 feet in width being 30 feet on each side of line of said road as surveyed over and across N $\frac{1}{2}$ of NW $\frac{1}{4}$ Sec.1, Lot 8, SW $\frac{1}{4}$, of NW $\frac{1}{4}$, NW $\frac{1}{4}$ of SW $\frac{1}{4}$ in sec. 1, SE $\frac{1}{4}$ of NE $\frac{1}{4}$ and NE $\frac{1}{4}$ of SE $\frac{1}{4}$ sec 2, the last named four quarter of quarter sections being in the Daniel Baughman D.L.C. #42. E $\frac{1}{2}$ of the NE $\frac{1}{4}$, sec 2, being in the Felix G. Iman D.L.C. #44, all in Tp 2 N.R.7 E. of W.M., said easment being of road record in the records of Skamania County, Washington and known as Permanent Highway Number Two.

Also all the right, title and interest of grantor in and to a strip of land 60 feet in width being 30 feet on each side of the center line of said State Road No 8 as surveyed over and across the NE $\frac{1}{4}$ of Sec 14, and NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of sec 14, SW $\frac{1}{4}$ sec 14, NW $\frac{1}{4}$ sec 11, all in the D.F. Bradford D.L.C. #37, Also Lots 1 and 7 sec 14, Lot 1 sec 15, Lots 1,2 and 3 sec 22, and NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of sec 22, all in tp 2 N.R 7 E. of W.M.

To Have and To Hold the same unto the State of Washington, for the purpose of public road forever.
