DOLLARS, TO US IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE BARGAINED, SOLD AND CONVEYED/UNTO IDA M. WENDLAND, PARTY OF THE SECOND PART, THE FOLLOWING DESCRIBED PREMISES, TO-WIT:

ALL THE NORTH HALF OF THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION TWENTY-TWO, IN TOWNSHIP THREE NORTH OF RANGE 10 EAST OF WILLAMETTE MERIDIAN, SKAMANIA COUNTY, WASHINGTON, CONTAINING 20 ACRES, MORE OR LESS.
