FOSTER TO GARWOOD.

The Grantors, I.I.Foster and Flora A. Foster, husband and wife, of Stevenson, Washington, For and in consideration of One Dollar and other values, in hand paid, convey and warrant to Jake Garwood, the following-described real estate, situated in the County of Skamania State of Washington, to-wit: A certain tract of land being a part of Lots Ten and Eleven of Stevenson Park Addition same being also a part of the Henry Shepard Donation Land Claim in Section 36 of Tp:3 North of Range 7 East of W.M., Skamania County, Washington, and more particularly described as follows: Beginning at a point 225 ft East of North 30 deg. 49 min. west 129.7 of S.W. corner of Lot 10 Stevenson Park Addition; thence North 30 deg. 49 min. West 70.3 feet (an iron pipe 1 in. in diameter) thence North 39 deg. 52 min. west, 188.9 ft (an iron pipe 1 in. diameter) (intersects east line of Strawberry road); thence North 4 deg. 06 min. West 283.5 ft. (this course is parallel to and 30 min. East of a course on center line of Strawberry Road between and which reads north 2 deg. 00 min. East as per plat on record in County Engineer's office, Skamania Co., Wash.) thence North 5 deg. .06 min. West 70.35 ft.
