ATTWELL TO GOEPEL

THIS INDENTURE Made This 25th day of November 1914 between J.F. Attwell and Bertha Attwell, his wife, parties of the first part, and William Goepel and Annetta M. Goepel, husband and wife, parties of the second part, witnesseth;

That for and in consideration of the sum of one dollar and other considerations, the receipt whereof is hereby acknowledged, the said parties of the first part do hereby bargain sell and convey unto the said parties of the second part, and to their heirs and assigns, all that certain tract or parcel of land lying and being in Skamania County, state of Washington, and bounded as follows, to-wit:

Commencing at the northwest corner of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of section 36 tp. 3 N. of Range 7 E of W.M. thence S 86 deg. 6' E. 966 feet, thence S 17 deg. 12' E 254 feet, thence S 52 deg. 19' E 259.10 feet, thence S 4 deg. 45' W 52 feet, thence N 86 deg. 6' W 1236.80 feet, to section line, thence north 405. feet to the place of beginning, containing ten acres more or less, also road therefrom described in former deed hereinafter mentioned.

Together with the appurtenances thereunto belonging.

This deed is given for the purpose of correcting error in description in former deed dated December 4th 1913 executed by the said first parties to the said second parties, and recorded on the 10th day of December 1914 in Book 0 of deeds at page 492, records of Skamania County. And the said parties of the first part will warrant and defend the title thereto against all lawful claims, except as against the said parties of the second part or any person or person claiming through them.
