WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Five Hundred and no/100 dollars, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey unto the said party of the second part, his heirs and assigns forever, all that tract or parcel of land lying and being in the County of Skamania and State of Washington, and described as follows, to-wit:

The West one-half of the South half of the South half of Section 20, Township two (2) North of Range 5, E.W.M. containing 80 acres more or less.

TO HAVE AND TO HOLD THE SAME, Together with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining, to the said party of the second part, his heirs and assigns forever.

And the said A.Hudson and Mary R.Hudson, M.C.Poindexter and Effie Poindexter parties of the first part, for them and their heirs, executors and administrators, do covenant with the said party of the second part, his heirs and assigns, that they are well seized in fee of the lands and premises aforesaid, and have good right to sell and convey the same in manner and form aforesaid; that the same are free from all encumbrances, And the above bargained and granted lands and premises, in the quiet and peaceful possession of the said party of the second part, his heirs and assigns, against all persons lawfully claiming, or to claim, the whole or any part thereof, the said parties of the first part will warrant and defend.
