Olson and Isabella Underwood, heirs of Ellen Underwood of Underwood, County of Skamania State of Washington in consideration of One dollar (\$1.00) and other values Dollars, to them paid by Apple Growers Union of White Salmon Valley, a corporation of State of Washington, have bargained and sold, and by these presents do grant, bargain, sell and convey unto said Apple Growers Union of White Salmon Valley, a corporation, its successors and assigns, all the following bounded and described real property, situated in the County of Skamania and State of Washington: That portion of lot six (6) of the townsite of Underwood described as beginning at the Northeast corner of said lot running thence westerly along the North line of said lot, four (4) feet, thence Southerly on a line parallel to the East line of said lot to the intersection with the right-of-way of the Spokane, Portland and Seattle Railway Company, thence Easterly along the North line of said right-of-way to the intersection with the East line of said lot, thence Northerly along the said East line of said lot to the point of beginning. together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and also all their estate, right, title and interest in and to the same, including dower and claim of dower.
