



DOUGLASS TO SHELLEY

THIS INDENTURE, made this 28th day of December, 1914 between A.L.Douglass and Emma Douglass his wife, parties of the first part, and R.D.Shelley party of the second part, witnesseth:

That the said parties of the first part, for and in consideration of the sum of Ten Hundred Sixty-three and 61/100 (\$1063.61/100) Dollars to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell and convey, and confirm unto the said party of the second part, and to his heirs and assigns forever; subject however to a certain mortgage held by the Bank of Stevenson in the sum of \$1000.00 together with all interest, costs and charges now due on same; the following described property;

Lots numbered 23-- 24 -- 25 -- 26 in Block Number 4 as shown on the official plat of the Town of Stevenson in the office of the Auditor in and for Skamania County, State of Washington.

Together with all and singular the tenements, hereditaments, and appurtenances thereunto belonging, or in anywise appertaint, and the rents, issues and profits thereof.

To have and to hold, all and singular the above mentioned and described premises, together with the appurtenances, unto the said party of the second part, and to his heirs and assigns forever. And the said party of the first part, and their heirs, the said premises, in the quiet and peaceable possession of the said party of the second part, his heirs, and assigns, against the said party of the first part, their heirs, and against all and every persons whomsoever, lawfully claiming or to claim the same, shall and will warrant, and by these presents forever defend; Subject, however to the above mentioned mortgage which the party of the second part hereby assumes.
