

Right of Way Deed.

IN THE MATTER OF State-Road No.8, otherwise known as the Columbia River road.

KNOW ALL MEN BY THESE PRESENTS, That E.P. Ash and Nellie E. Ash his wife, of the County of Skamania, in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of One Dollar, paid to them, the receipt whereof is hereby acknowledged, have bargained, granted, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the State of Washington, the following described parcel of land, situated in Skamania County, in the State of Washington, to-wit: A strip of land 60 feet wide, being 30 feet on each side of said road as surveyed over and across the following described tracts of land; Beginning 1850 feet east of the quarter corner of Section 11, Township 2 North Range 7 East W.M. running thence 850 feet east to the Right of Way of the Spokane Portland and Seattle Railway; thence following the Right of Way line of said S.P. & S. Ry. to a point 1000 feet north of the centre line thru section 11 of said township and range; thence west 1130 feet, thence south 1000 feet to the place of beginning. Also the following described tract; commencing 997 feet west of the intersection of the north line of above described tract of land with the north line of the S.P. & S. Ry. Right of Way, thence North 43 degrees west 400 feet to the County road, as now established and platted; thence south 69 degrees 53 minutes west 106 feet along said County road to Bowles creek, thence south 43 degrees east following said creek 350 feet more or less to the east and west line of said tract, thence east 135 feet more or less to the place of beginning both tracts of land hereby described together aggregating 22 acres more or less. Also beginning at a point where the north east corner of that tract of land above described joins the westerly right of Way line of the S.P. & S. Ry. running thence west along the north line of said above described tract belonging to E.P. Ash 995 feet, thence north 43 degrees west 275 feet more or less to a point 200 feet north of the south line projected and above described, thence east parallel with the south line as above described, and 200 feet distant therefrom, 1230 feet more or less to westerly Right of Way line of the S.P. & S. Ry. thence southerly along said Right of Way line to the place of beginning.

Excepting therefrom all Rights of Way and appurtenances appropriated by order of the Superior Court of the State of Washington for Skamania County as described in Book of Deeds "O" page 41 of the records of said County.

TO HAVE AND TO HOLD the same unto the State of Washington for the purpose of a public road forever.
