SUPPLEMENTAL TRUST DEED.

WHEREAS, SKAMANIA LIGHT & POWER COMPANY, A WASHINGTON CORPORATION, HEREINAFTER CALLED THE PARTY OF THE FIRST PART, HERETOFORE EXECUTED ITS TRUST DEED TO LUMBERMEN'S TRUST COMPANY, AN OREGON CORPORATION, AS TRUSTEE, HEREINAFTER CALLED THE PARTY OF THE SECOND PART, TO SECURE THE PAYMENT OF 350 BONDS IN THE AGGREGATE PRINCIPAL SUM OF \$35,000.00, ON THE 22ND DAY OF MAY, 1922, IN BOOK "P" OF MORTGAGES AT PAGE 110, RECORDS OF SKAMANIA COUNTY, WASHINGTON, AND WAS THEREAFTER AND ON JUNE 13, 1922, RECORDED IN BOOK 15 OF MORTGAGES ON PAGE 277, RECORDS OF HOOD RIVER COUNTY, OREGON, AND

WHEREAS, IT WAS THE INTENT AND PURPOSE OF THE PARTIES OF SAID TRUST DEED THAT IT SHOULD COVER AND CONVEY ALL OF THE PROPERTY OF THE PARTY OF THE FIRST PART SAVE AND EXCEPT CERTAIN PARCELS OF REAL ESTATE WHICH BY THE TERMS OF SAID TRUST DEED ARE EXPRESSLY EXCEPTED THEREFROM, AND

WHEREAS, BY INADVERTENCE IN THE PREPARATION OF SAID TRUST DEED AND BY THE MUTUAL MISTAKE OF THE PARTIES THERETO, THE DESCRIPTION OF CERTAIN PROPERTY BELONGING TO THE PARTY OF THE FIRST PART WAS OMITTED THEREFROM, AND

WHEREAS, THE PARTY OF THE FIRST PART STILL OWNS ALL THE PROPERTY OWNED AT THE DATE OF SAID TRUST DEED AND HAS ACQUIRED AND OWNS OTHER PROPERTY ADDITIONAL THERETO,

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, THAT IN CONSIDERATION OF THE PREMISES AND FOR THE PURPOSE OF SECURING THE PAYMENT OF THE PRINCIPAL AND INTEREST OF THE AFORESAID BONDS, AND TO CARRY OUT THE SAID INTENT AND PURPOSE OF THE PARTIES HERETO THE PARTY OF THE FIRST PART HAS GRANTED, BARGAINED, SOLD, TRANSFERRED, ASSIGNED, MORTGAGED, CONVEYED AND WARRANTED, AND BY THESE PRESENTS DOES GRANT, BARGAIN, SELL, TRANSFER, ASSIGN, MORTGAGE, CONVEY AND WARRANT UNTO THE PARTY OF THE SECOND PART ITS SUCCESSORS AND ASSIGNS IN TRUST AS HEREINAFTER PROVIDED ALL OF ITS PROPERTY OF EVERY KIND AND DESCRIPTION WHEREVER SITUATED, AND PARTICULARLY ITS ELECTRIC LIGHT AND POWER PLANTS IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, AND IN THE COUNTY OF HOOD RIVER, STATE OF OREGON, AND ANY AND ALL PROPERTY OF WHATSOEVER DESCRIPTION TO BE HEREAFTER ACQUIRED BY THE PARTY OF THE FIRST PART AND PARTICULARLY ALL AND SINGULAR THE CORPORATE RIGHTS, POWERS, PRIVILEGES, FRANCHISES, PROPERTIES, BUILDINGS, MACHINERY, ELECTRIC OR HYDRAULIC FIXTURES, APPLIANCES, APPURTENANCES, TRANSMISSION AND DISTRIBUTION LINES, CABLES, WIRES, POLES, TRANSFORMERS, METERS, SWITCHES, FLUMES, PIPE LINES, WATER WHEELS AND GOVERNORS, GENERATORS, SWITCH BOARD EQUIPMENT, TOOLS, SUPPLIES AND MATERIALS NOW OWNED OR HEREAFTER TO BE ACQUIRED BY THE PARTY OF THE FIRST PART, EXCEPTING, HOWEVER, FROM THIS SUPPLEMENTAL TRUST DEED THE SAME REAL PROPERTY WHICH WAS EXCEPTED FROM SAID TRUST DEED DATED MAY 12, 1922, TO-WIT; THAT PORTION OF THE PREMISES DESCRIBED IN SAID TRUST DEED WHICH LIES WITHIN
