KNOW ALL MEN BY THESE PRESENTS, THAT I JOHN ZINIKER OF WASHOUGAL WASHINGTON FOR VALUABLE CONSIDERATION TO ME IN HAND PAID, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO HEREBY RELEASE THE FOLLOWING DESCRIBED REAL ESTATE, SITUATED IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON, TO-WIT:
