S. GOLD COIN, WITH INTEREST THEREON AT THE RATE OF EIGHT PER CENT PER ANNUM, IF PAID WHEN DUE, IF NOT PAID WHEN DUE, TEN RER CENT PER ANNUM FROM DATE. INTEREST PAYABLE QUARTERLY AND INTEREST TO BECOME IMMEDIATELY DUE AND COLLECTIBLE.
