Arnold, party of the second part, witnesseth, that the said party of the first part for and in consideration of the sum of \$1.00-----Lawful money, the receipt whereof is hereby confessed does hereby grant, convey, and warrant unto the said party of the second part, his heirs and assigns the following real estate in Skamania County, Washington, to-wit: Commencing at a point on the west line of Block 8 of the town of Stevenson N 34 deg. 30' W 100 feet from the northerly line of Second Street, thence S 55 deg. 30' W 40 feet, thence N 34 deg. 30' W. 77.2 feet, to the southwesterly line of the J.P. Gillette Property, thence in a southeasterly direction along the said J.P. Gillette property to a point N 34 deg. 30' W 48 feet from the place of beginning, thence S 34 deg. 30' E to the place of beginning.

TO HAVE AND TO HOLD, the same unto the said party of the second part and his heirs and assigns forever.

And the said party of the first part, for himself and for his heirs, administrators executors and assigns, hereby covenants and agrees that he is the owner of the said premises in fee simple, that he is lawfully seized of the same, that the same are free from incumbrances except mortgages held by the second party. and that he and they will warrant and defend the title thereto against all persons lawfully claiming the same, except as to said mortgages.
