NOW, THEREFORE, THIS INDENTURE WITNESSETH: THAT THE SAID EARL W. KEYS AND MARY A. KEYS, HIS WIFE, PARTIES OF THE FIRST PART, IN CONSIDERATION OF THE PREMISES AND OF THE EXECUTION OF THE SAID DEED TO THE PARTIES OF THE FIRST PART BY THE SAID PARTY OF THE SECOND PART, DOES BY THESE PRESENTS GRANT, RELEASE, QUIT CLAIM, AND SET OVER UNTO THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS ALL THAT PART OF THE SAID MORTGAGED LANDS, DESCRIBED AS FOLLOWS, TO-WIT:

BEGINNING AT THE NORTHEAST CORNER OF LOT TWO (2), SECTION TWENTY-NINE  
 (29), TOWNSHIP THREE (3), NORTH OF RANGE TEN (10); EAST OF THE WILLAMETTE MERIDIAN,  
 RUNNING THENCE WEST ALONG THE SECTION LINE BETWEEN SECTIONS TWENTY (20) AND TWENTY-  
 NINE (29), THIRTY (30) RODS, THENCE SOUTH FIFTY THREE AND ONE/THIRD (53 1/3) RODS,  
 THENCE EAST THIRTY (30) RODS, THENCE NORTH ALONG THE QUARTER SECTION LINE FIFTY-  
 THREE AND ONE-THIRD (53 1/3) RODS TO THE PLACE OF BEGINNING, CONTAINING TEN (10).  
 ACRES MORE OR LESS, LOCATED IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON.  
 TOGETHER WITH ALL AND SINGULAR, THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES  
 THERETO BELONGING OR IN ANY WISE APPERTAINING; AND ALL THE LIEN, RIGHT, TITLE AND  
 INTEREST OF THE SAID PARTIES OF THE FIRST PART, OF, IN AND TO THE SAME, TO THE  
 INTENT THAT THE LANDS HEREBY CONVEYED AND RELEASED SHALL FOREVER BE DISCHARGED FROM
