MERTZ TO MERTZ

THIS AGREEMENT Made this 28th day of May 1914 between F. Mertz party of the first part and Helen Mertz, his wife party of the second part, witnesseth;

That, whereas, it is impossible for the parties hereto to longer live together as husband and wife, and in order to settle property rights between the said parties, it is hereby agreed that the said party of the first part shall and may have as his own and separate property ~~all interest of whatsoevor kind in and to the following real property~~ all interest of whatsoevor kind in and to the following real property to-wit: Commencing at the Northeast corner of the Northwest quarter of the southwest quarter of section 22 tp.2 N. R. 6 E. of W.M. thence south to the present county road, thence northwesterly along the north line of said county road to where said north line intersects the north line of the said northwest quarter of the southwest quarter aforesaid, thence east to the place of beginning containing 16 acres, and all proceeds that may arise out of the sale of said land, including notes given therefor and mortgage thereon.

All other property now owned by said parties, either as community property, or as separate property of said second party shall be and remain the property of said second party.

And it is further agreed between the parties that no claim, other than above provided, shall or may be made by either party to property of either, or to property of the community, owned at the present time, or that may be acquired by either hereafter.
