THE WEST HALF OF THE SOUTHWEST QUARTER ($W\frac{1}{2}$ OF $SW\frac{1}{4}$) OF SECTION FOURTEEN (14) AND THE EAST HALF OF THE SOUTHEAST QUARTER ($E\frac{1}{2}$ OF $SE\frac{1}{4}$) OF SECTION FIFTEEN (15) IN TOWNSHIP FOUR (4), NORTH OF RANGE SEVEN (7), EAST OF WILLAMETTE MERIDIAN, CONTAINING ONE HUNDRED SIXTY (160) ACRES;

TRACT XXVII. THE SHORE LANDS IN FRONT OF SECTIONS TWENTY-EIGHT (28), TWENTY-NINE (29), THIRTY-TWO (32) AND THIRTY-THREE (33), IN TOWNSHIP THREE (3), NORTH OF RANGE EIGHT (8), EAST OF WILLAMETTE MERIDIAN, CONTAINING FIFTY-TWO AND SEVENTY-FOUR ONE HUNDREDTHS (52.74) ACRES;

TRACT XXVIII. THAT PORTION OF THE ROBINS DONATION LAND CLAIM IN TOWNSHIP THREE (3) NORTH, RANGE EIGHT (8) EAST OF THE WILLAMETTE MERIDIAN, LYING NORTH OF THE LINE RUNNING BETWEEN SECTIONS TWENTY-SEVEN (27) AND THIRTY-FOUR (34); ALSO THE NORTH HALF OF THE SOUTHEAST QUARTER ($N\frac{1}{2}$ OF $SE\frac{1}{4}$), AND SOUTHEAST QUARTER OF THE NORTHEAST QUARTER ($SE\frac{1}{4}$ OF $NE\frac{1}{4}$) OF SECTION THIRTY (30) IN TOWNSHIP THREE (3) NORTH, RANGE NINE (9) EAST OF THE WILLAMETTE MERIDIAN, AND THE NORTH HALF OF THE NORTHWEST QUARTER ($N\frac{1}{2}$ OF $NW\frac{1}{4}$), THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER ($SE\frac{1}{4}$ OF $NW\frac{1}{4}$), AND LOT ONE (1) OF SECTION TWENTY-SIX (26) IN TOWNSHIP THREE (3) NORTH, RANGE EIGHT (8) EAST OF THE WILLAMETTE MERIDIAN; EXCEPTING THEREFROM THE FOLLOWING DESCRIBED PROPERTY, TO-WIT:
