TOGETHER WITH THE TENEMENTS, HEREDITAMENTS, RICHTS, PRIVILEGED AND APPURTENANCES,

NOW OR HEREAFTER BELONGING TO OR USED IN COUNCITION WITH THE ABOVE DESCRIBED PREMISES;

AND ALL PLUMBING, LIGHTING, HEATING, COOKING, COOLING, VENTILATING, ELEVATING,

WATERING, AND IRRIGATING APPARATUS AND FIXTURES, NOW OR HEREAFTER BELONGING TO OR

USED IN CONNECTION WITH THE ABOVE DESCRIBED PREMISES; AND TOGETHER WITH ALL WATERS

AND WATER RIGHTS OF EVERY WIND AND DESCRIPTION AND HOWEVER EVIDENCED OR MANIFESTED,

WHICH NOW OR HEREAFTER MAY BE APPORTENANT TO SAID PREMISES OR ANY PART THEREOF,

OR INCIDENT TO THE OWNERSHIP THEREOF, OR ANY PART THEREOF,

THEREWITH; AND TOGETHER WITH ALL THE RENTS, ASSUES AND PROFITS OF THE MORTGACED

PROPERTY.

THIS MORTGAGE SECURED THE PERFORMANCE OF THE COVENANTS AND ACREEMENTS
HEREINAFTER CONTAINED AND THE PAYMENT OF THE DEBT REPRESENTED BY ONE PROMISSORY
NOTE MADE BY THE MORTGAGORS TO THE ORDER OF THE MORTGAGEE, OF EVEN DATE HEREWITH,
FOR THE PRINCIPAL SUM OF THIRTEEN HUNDRED DOLLARS (\$1300.00), WITH INTEREST THEREON
FROM DATE UNTIL MATURITY AT THE RATE OF 6 PER CENT PER ANNUM, PAYABLE SEMI-ANNUALLY,
ON THE WHOLE OF SAID PRINCIPAL SUM FROM TIME TO TIME REMAINING UNPAID, BOTH PRINCIPAL AND INTEREST BEING PAYABLE TO THE SAID MORTGAGEE AT ITS OFFICE IN THE CITY
OF SPOKANE, STATE OF WASHINGTON, ON AN AMORTIZATION PLAN IN INSTALLMENTS AS IN THE
SAID PROMISSORY NOTE PROVIDED. SAID NOTE MATURES IN 33 YEARS FROM DATE HEREOF,
UNLESS MATURED SOONER BY EXTRA PAYMENTS ON ACCOUNT OF PRINCIPAL; AND PROVIDED ALSO
FOR REASONABLE ATTORNEY'S FEE IN ADDITION TO OTHER COSTS IN CASE OF SUIT THEREON.

EACH OF THE MORTGAGORS COVENANTS THAT THEY ARE LAWFULLY SEIZED OF SAID PREMISES IN FEE SIMPLE, HAVE BOOD RIGHT AND LAWFUL AUTHORITY TO CONVEY AND MORTGAGE SAID PREMISES IN THE MANNER AND FORM AFORESAID, AND THAT SAID PREMISES ARE FREE FROM ENCUMBRANCE, AND EACH OF THE MORTGAGORS SHALL AND WILL WARRANT AND DEFEND THE SAME FOREVER AGAINST THE LAWFUL CLAIMS AND DEMANDS OF ALL PERSONS WHOMSOEVER, AND THIS COVENANT SHALL NOT BE EXTINGUISHED BY ANY FORECLOSURE HEREOF, BUT SHALL RUN WITH THE LAND.

AND EACH OF THE MORTGAGORS FURTHER COVENANTS AND AGREES:

TO PAY ALL DEBTS AND MONEYS SECURED HEREBY, WHEN FROM ANY CAUSE THE SAME SHALL BECOME DUE;

NOT TO PERMIT OR SUFFER ANY TAX, ASSESSMENT, OR OTHER LIEN OR ENCUMBRANCE PRIOR TO THE LIEN OF THIS MORTGAGE, TO EXIST AT ANY TIME AGAINST SAID PREMISES;

TO PROCURE AND DELIVER TO THE MORTGAGEE BEFORE ANY INTEREST OR PENALTY.

ON ANY TAX OR ASSESSMENT SHALL BEGIN TO RUN OR ACCRUE, THE OFFICIAL RECEIPT OF THE

PROPER OFFICER SHOWING PAYMENT THEREOF;

NOT TO COMMIT OR SUFEER WASTE UPON SAID PREMISES, AND TO KEEP ALL ORCHARDS ON SAID LAND PROPERTY IRRIGATED, CULTIVATED, SPRAYED AND CARED FOR;

TO COMPLETE ALL BUILDINGS IN COURSE OF CONSTRUCTION, OR ABOUT TO BE CONSTRUCTED THEREON, WITHIN A REASONABLE TIME FROM THE DATE HEREOF IN ACCORDANCE WITH THE AGREEMENT HERETOFORE MADE BETWEEN THE PARTIES HERETO;

TO KEER ALL BUILDINGS IN GOOD REPAIR AND UNCEASINGLY INSURED AGAINST LOSS OR DAMAGE BY FIRE IN MANNER AND FORM SATISFACTORY TO THE MORTGAGEE, AND IN A COMPANY OR COMPANIES TO BE APPROVED BY THE MORTGAGEE, IN SUCH SUM AS SHALL BE
