DEED TO PIPE LINE.

THIS INDENTURE made and entered into by and between Henry Seaborg and Anna Seaborg husband and wife, the of Edgewater, Washington, the parties of the first part, and William Butler, of the same place, party of the second part.

WITNESSETH: That the said parties of the first part for and in consideration of the sum of One Dollar . lawful money of the United States to them in hand paid thereceipt whereof is hereby acknowledged, together with other valuable considerations, do hereby bargain, sell, grant and convey unto the party of the second part, his heirs, executors administrators and assigns and undivided equal joint and several common interest in and to a pipe line and right of way for the purpose of building and maintaining a a pipe line to carry and convey water for domesticeuses and purposes to the premises of the second party on; upon and across the following described lands belonging to the parties of the first part In Skamania County, State of Washington, to-wit:

Beginning at the corner of Sections 26,27, 34; and 35 in Township 2 north of Range 6 East of the Willamette Meridian; thence south var. 21 deg. 30' E 20 chs. thence west var. 21 deg. 30' E 20 chs. thence west var 21 deg. 30' E 11.50 chs. to center of creek where stake is set on bank of creek, from which corner bears west 38 maxxx links; thence following center of creek for boundary line S 54 deg. E 207 chs; thence Shocdeg. E 6.72 chs. thence S 20 deg.
