 In Section Thirty (30): Lots One (1) and Two (2) and Southeast quarter of Northwest quarter.
 In Township Six (6) North of Range Ten (10) East; same base and meridian:
 In Section Fourteen (14): Northwest quarter of Northwest quarter;
 In Section Nineteen (19) Southwest quarter of Northeast quarter, and South half;
 In Section twenty (20): West half of Southwest quarter;
 In Section Thirty (30): Northeast quarter of Northeast quarter.
 In Township six (6) North of Range Eleven (11) East; same base and meridian.
 In Section twenty (20): West half of Southwest quarter, Southeast quarter of Southwest quarter;
 In Section Twenty-One (21) East half of East half;
 In Section Twenty-nine (29): Northwest quarter of Northwest quarter.
