WITNESSETH: That the said party of the first part, for and in consideration of the sum of One Dollars of the United States of America to her in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged does by these presents, remise, release and forever quit-claim unto the said parties of the second part, ~~the said parties of the second part, the receipt whereof is hereby acknowledged~~ and to their heirs, assigns, the following described tract, lot or parcel of land, situated, lying and being in the County of Skamania, State of Washington, particularly bounded and described as follows, to-wit:

Commencing at a point 31.69 chains east and 4.77 chains north from the section corner 29, 30, 31, and 32 (variation at corner 20 deg. East); thence West 183 links to County road; thence north 16 deg. 30' E. 208 links on County road; thence North 407 links on County road; thence north 47 deg. east 205 links where line leaves road; thence south 60 deg. E. 446 links; thence south 23 deg. E 65 links; thence south 18 deg. E. 210 links thence south 61 deg. W 182 links; thence south 2 deg. E 131 links; thence south 45 deg. W 180 links; thence West 255 links to starting point containing 5 acres more or less. Excepting therefrom the right of way heretofore deeded to S.P. & S. Ry. Co. Said described land being in Section 29, Lot 1, Twp. 3 N.R. 8 East of W.M.
