NORD TO THE PUBLIC.

KNOW ALL MEN BY THESE PRESENTS that I, Hulda Nord, am a citizen of the United States and of the State of Washington and a resident of Skamania County, herein. That I am over the age of twenty-one years and am a widow and the head of a family. That I am residing on the land described as follows, to-wit:
