THIS INDENTURE, MADE THIS 1ST DAY OF MAY IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE BETWEEN GEORGE F. BRESLIN AND KATHERINE L. BRESLIN, HIS WIFE, PARTIES OF THE FIRST PART, AND JOHN W. ATTWELL PARTY OF THE SECOND PART:
