All of the south one half of the southwest quarter of the northwest quarter of Section twenty four (24), in Township three (3) North of Range eight East of Willamette Meridian, containing twenty (20) acre according to the Government Survey, in Skamania co. Washington.

TO HAVE AND TO HOLD the above granted premises, with all the rights, easements, and appurtenances thereto belonging unto the said Christian Blum (his) heirs and assigns forever.
