

DECLARATION OF HOMESTEAD

BE IT KNOWN THAT I, ETTA RAMSEY VINCENT, do hereby declare that I am a married woman, the wife of John Vincent, that my husband, the said John Vincent, has not made any declaration of homestead, and that I therefore make this declaration for the joint benefit of myself and my said husband.

That I am, at the time of making this declaration, actually residing on the premises hereinafter described and claim said premises as a homestead.

That the hereinafter described property is my separate property being inherited by me from my father, Edward Ramsey.

The premises so claimed by me as a homestead are the real property situate in the County of Skamania, State of Washington, and described as follows, to-wit:

A Tract of land described as: Beginning at point known as the quarter section corner between section 21 and 28 township three (3) North of Range ten (10) East of the Willamette Meridian, being also the Southwest corner of the Edward Ramsey Estate; Thence East 1120 feet, thence North 33 degrees East 52 feet, thence North 2595 feet, thence West 1156 feet, thence South 2640 feet to the point of beginning, containing 62.15 acres more or less, excepting a five acre tract in N.W. corner belonging to A.J. Haynes, together with the dwelling house and other buildings and appurtenances thereon.

That I estimate the actual cash value of the said premises to be the sum of Two Thousand and no/100 \$ (\$2,000.00) Dollars.
