THIS INDENTURE WITNESSETH, That Hiram S. Mickley, of Cape Horn, County of Skamania, State of Washington, party of the first part, for and in consideration of the sum of Ten Dollars (\$10) and other good and valuable considerations, in lawful money of the United States of America, to him in hand paid by Etta L. Mickley, his wife, of the same place, party of the second part, has GRANTED, BARGAINED and SOLD, and by these presents does Grant, Bargain, Sell and Convey unto the said party of the second part, and to her heirs and assigns, the following described real property, situate, lying and being in the County of Skamania, and State of Washington, to-wit:

The North half of the Southeast quarter (N. $\frac{1}{2}$ of S.E.) of Section Four (4), in Township One (1) North, of Range Five (5) East, of the Willamette Meridian, containing Eighty (80) acres.

TO HAVE AND TO HOLD the said premises, with all their appurtenances, unto the said party of the second part, and to her heirs and assigns forever; and the said Hiram S. Mickley, party of the first part, for himself and for his heirs, executors and administrators, does hereby covenant to and with the said party of the second her heirs and assigns, that he is the owner in fee simple of said premises, and that they are free from all encumbrances, except waiver for right of way for County Road in favor of said Skamania County executed by Hiram S.
