SECTION ONE (1). ALL THE TIMBER ON LOTS ONE (1) AND TWO (2) AND THE SOUTH HALF OF THE NORTHEAST QUARTER ($S\frac{1}{2}$ OF $NE\frac{1}{4}$) WITH RIGHT TO ENTER UPON THE LAND AND REMOVE THE TIMBER AT ANY TIME WITHIN TWENTY-FIVE YEARS FROM APRIL 10, 1903. LOTS THREE (3) AND FOUR (4) AND THE SOUTH HALF OF THE NORTHWEST QUARTER ($S\frac{1}{2}$ OF $NW\frac{1}{4}$) AND THE NORTH HALF OF THE SOUTH HALF ($N\frac{1}{2}$ OF $S\frac{1}{2}$) SUBJECT TO MINERAL RESERVATION AND RESERVATION OF RIGHT TO CARRY ON MINING OPERATIONS, ALSO RIGHT-OF-WAY FORTY (40) FEET WIDE RESERVED ACROSS THE LAND FOR A LOGGING ROAD.
