in it is therefore made a condition precedent to this dedication that title to the fore going dedicated strip of land for said public road and use thereof shall not vest in the public or in said Skamania County until said vacation has been completed, and should said vacation be abandoned or should it not be completed within a reasonable time, then and in that event the temporary possession with which the county has been intrusted at this time by the grantee herein may be recovered by the grantor in as much as no title hereunder shall vest until said vacation has been consummated.
