THIS INDENTURE, Made this 21st day of February, A.D. 1916, between Russel W. Brock and Minnie B. Brock, his wife parties of the first part, and Clarence C. Brock, party of the second part.

WITNESSETH, That the said part__ of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey, unto the said party of the second part, his heirs and assigns forever, all that tract or parcel of land, lying and being in the County of Skamania and State of Washington, and described as follows, to-wit:

The northwest quarter (NW $\frac{1}{4}$) of Southwest Quarter (SW $\frac{1}{4}$) of Section 11, Township 3 North of Range 9 East of Willamette Meridian, containing 40 acres more or less.

TO HAVE AND TO HOLD THE SAME, Together with all the hereditaments and appurtenances thereunto belonging, or in anywise appertaining, to the said party of the second part, his heirs and assigns forever. And the said Russel W. Brock and Minnie B. Brock parties of the first part, for themselves and their heirs, executors and administrators, do covenant with the said party of the second part, his heirs and assigns, that they well seized in fee of the lands and premises aforesaid, and have good right to sell and convey the same in manner and form aforesaid; that the same are free from all encumbrances. And the above bargained and granted/lands and premises, in the quiet and peaceful possession of the said party of the second part, his heirs and assigns, against all persons lawfully claiming, or to claim, the whole or any part thereof, the said parties of the first part will warrant and defend.
