ALSO: THE TIMBER ONLY ON THAT PORTION OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER (NE $\frac{1}{4}$  OF NE $\frac{1}{4}$ ) OF SECTION SEVEN (7), TOWNSHIP THREE (3) NORTH, RANGE EIGHT (8) EAST OF WILLAMETTE MERIDIAN, LYING NORTH OF PANTHER CREEK, WITH FULL LIBERTY AND AUTHORITY UNTIL THE FIRST DAY OF JANUARY, 1925, TO FELL, CUT AND REMOVE SAME;

ALSO: THE TIMBER ONLY ON THAT PORTION OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER (SW $\frac{1}{4}$  OF NW $\frac{1}{4}$ ) OF SECTION EIGHT (8), LYING BETWEEN THE FORKS OF PANTHER AND BEAR CREEKS, IN TOWNSHIP THREE (3) NORTH, RANGE EIGHT (8) EAST OF WILLAMETTE MERIDIAN, WITH FULL LIBERTY AND AUTHORITY UNTIL THE FIRST DAY OF JANUARY, 1924, TO FELL, CUT DOWN AND REMOVE SAME;
