

AND BEAR CREEKS, IN TOWNSHIP THREE (3) NORTH, RANGE EIGHT (8) EAST OF WILLAMETTE MERIDIAN, WITH FULL LIBERTY AND AUTHORITY UNTIL THE FIRST DAY OF JANUARY, 1924, TO FELL, CUT DOWN AND REMOVE THE SAME;
