NORTHERN PACIFIC RAILWAY COMPANY. THIS DEED made the twenty third day of March in the year of our Lord one thousand nine hundred and fifteen by the NORTHERN PACIFIC RAILWAY COMPANY, a corporation of the State of Wisconsin, grantor, to Eleanor Yale, in the County of Clarke and State of Washington, grantee, WITNESSETH: The Grantor, in the consideration of the sum of Three hundred thirty (\$330.00) Dollars, unto it paid, the receipt whereof is acknowledged, remises, releases and quit claims unto the grantee, her heirs and assigns, all its right, title and interest in and to the following described tract of land situate in the County of Skamania and State of Washington. to-wit: Southwest quarter of southwest quarter (SW $\frac{1}{4}$ of SW $\frac{1}{4}$) of section thirty-two (32), in Township seven (7) North, of Range six (6) East of the Willamette Meridian, containing, according to the United States Government Survey, forty (40) acres, more or less; subject as reserved in the patent from the United States, to a right of way therein for ditches or canals constructed by authority of the United States.
