THE EAST $\frac{1}{2}$ OF THE SOUTHWEST QUARTER OF SECTION SEVENTEEN (17), IN TOWNSHIP 3 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN, IN THE STATE OF WASHINGTON, CONTAINING 80 ACRES MORE OR LESS.
