LOVEGREN (BY SHERIFF) TO BROWN.

THIS INDENTURE, Made this 24th day of March, 1916, between S.L.Knox, Sheriff of the County of Skamania State of Washington, party of the first part, and Edward L. Brown, of the County of Clark State of Washington, party of the second part, witnesseth: THAT WHEREAS, By virtue of the special execution issued out of and under the seal of the Superior Court of the State of Washington, in and for Skamania County on the 14th day of January, 1915, in favor of Edward L.Brown, and against Edward N.Lovegren, Gustaf Lovegren, et al, and to the Sheriff of said County duly directed and delivered, commanding him to sell the property hereinafter described, at public auction, according to law, as by the said special execution, reference being thereunto had, more fully appears; AND WHEREAS, Pursuant to said special execution the said Sheriff on the 20th day of March, 1915 did duly sell the premises herein after described at public auction according to law, to Edward L.Brown, who was the highest bidder therefor, for the sum of \$1936.60 Nineteen Hundred Thirty Six and sixty 1./100 Dollars lawful money of the United States of America, which was the highest and best sum bidden and the whole price paid therefor, the said Sheriff having first given due and legal notice of the time and place of said sale, according to law;
