

GROSSEN TO THE PUBLIC

DECLARATION OF HOMESTEAD.

KNOW ALL MEN BY THESE PRESENTS, that I, A. Grossen, of Cape Horn, Skamania County, State of Washington, for the benefit of myself and family do hereby publish and declare the hereinafter described tract or parcel of real property, together with the hereditaments and appurtenances thereunto belonging or in anywise appertaining, lying and being in the County of Skamania State of Washington, to be my homestead, and in support of said declaration of homestead do state and declare as follows:

1. That I, A. Grossen am the person making this declaration and that I am the head of a family, to wit: I am the husband of Carrie Grossen who, with our minor children, is depending on me for support.

2. That I, with my family, am living on said premises and intend to reside thereon and claim the same as my homestead.

3. The premises hereby declared to be my homestead are lying and being in Skamania County, State of Washington, particularly bounded as follows: Commencing in center of County road opposite the N.W. Cor. of School Lot in Section Three (3) Tp. One (1) N. Range Five (5) E. W. M. thence following center of County Road 1° 46' East 10.52 chains to intersection of county road. Thence along center of this County Road N. 87° 46' East 10.08 Chains; thence S 1° 46' W 9.30 Chains to North line of School lot; thence along North line of School lot S 80° 44' W 10.40 Chains to place of beginning. Being a tract of land containing ten (10) acres, more or less, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

4. I estimate the actual cash value of said tract of land and premises to be \$1800.00.
