INMAN TO INMAN

KNOW ALL MEN BY THESE PRESENTS THAT I, Frank Ross Inman, (single and unmarried), of Ilwaco, of the County of Pacific in the State of Washington, for and in consideration of the sum of Five Hundred Dollars to me in hand, paid by W. K. Inman, of the same place, the receipt whereof I do hereby acknowledge I have granted, bargained and sold and do by these presents grant, bargain, sell, convey and confirm unto the said W. K. Inman, and to his, heirs and assigns forever, all that certain tract of land lying and being in the County of Skamania, and State of Washington, and particularly described as follows, to wit: All of my right, title and interest, in and to the undivided one half off the following described tracts of land, to wit: All that portion of land commencing at a post in the center of the South West Quarter of Section 25, Twp 3, North Range 7½ E.
