ASH TO STEVENSON WATER COMPANY

THIS INDENTURE, Made this 22nd day of April in the year of our Lord One Thousand Nine Hundred and sixteen Between E. P. Ash and Nellie E. Ash, his wife, the parties of the first part, and The Stevenson Water Company, a Washington Corporation, the party of the second part:
